√ Communicative English Program (48 Hrs.)

1. Deliverables:

- a. The Course shall be operated within the College premises and all infrastructural facilitiesessential in running the course(viz. Computer, Projector, Chalk, Board, Marker etc.)shall be arranged in the College premises and will be the responsibility of the College authority.
- b. College will provide minimum 50 number of students for each training.
- c. The duration of the training will be 48 Hrs. approximate 3 months. Duration per class will be 2 Hrs, twice weekly.
- d. GTTI will provide softcopy of Study material to each student via mail.
- e. Assessment will be conducted via GTTI after completion of the training.
- f. Assessment & Participation Certification will be provided by GTTI and College jointly, mentioning both name and logo.
- g. The Collegewill maintain the room allotted for running the said course in good condition and shall promptly make all reasonable necessary repairs and replacements thereto in order to keep the premise in good condition to run the course.
- h. GTTI will provide necessary inputs formobilization of student towards next session program in order to make it commercially viable.
- College will provide the writing permission to use its name and logo for the joint certification of the said program.
- j. Both the Parties shall be at liberty to withdraw or cancel the MoU after giving due notice of at least 02 months if:

Both the parties fail to achieve the bare minimum number of students for the learning programs, in aggregate, which in the opinion of both the parties would affect its goodwill and this MOU will lose its commercial viability, or for any other reason thereof.

2. Terms of MoU:

- a) This MOU shall be valid for a period of 1 (one) year from the date of execution and can be renewed for a further period of 3 years on mutual consent and satisfaction to both contracting parties.
- b) The GTTI and College Authorityshall jointly review the progress of each batch.
- GTTI will submit weekly progress report of the participating students for record keeping before the Principal, BCC.
- d) This MoU may be amended, altered or modified from time to time mutually decided by both the parties, however no such alteration, modification
